Abstract:

The subtitles of this talk might be "post-modern criminal behavior" or "life in a shadow economy." It starts with an overview of the role of crime in general, and digital crime in particular, in the shadow economies of the world and illustrates this via a sequence of specific criminal activities that have been studied by the author. Exploits covered in this talk include (1) "gift cards and transnational money laundering," "Hookers, Tweakers, and Hotel Room Keys," and (3) "Fungible Credentials and Bank Card Forensics." If your organization is interested in the latest digital exploits by the forces of darkness, this talk is for you.

Bio:

Hal Berghel is currently Professor and Director of the School of Informatics and Associate Dean of the Howard R. Hughes College of Engineering, and Professor and past-Director of the School of Computer Science, at the University of Nevada , Las Vegas. He is also founding Director of both the Center for Cybersecurity Research, and the Identity Theft and Financial Fraud Research and Operations Center. Berghel has held a variety of research and administrative positions in industry and academia during his thirty-year career in computing. His current research focuses on computing and network security, digital forensics, and digital crime. He is also a popular columnist, author, talk show guest, and keynote speaker.

Dr. Berghel is a Fellow of both the Institute for Electrical and Electronics Engineers and the Association for Computing Machinery, and serves both societies as ACM Distinguished Lecturer and an IEEE Distinguished Visitor. He has received the ACM Outstanding Lecturer of the Year Award four times and was recognized for Lifetime Achievement in 2004. He has also received both the ACM Outstanding Contribution and Distinguished Service awards. He is also the founder and owner of Berghel.net, a consultancy serving business and industry, and co-owner of BC Innovations Management, a startup company in IP and DRM.

Directions to The Riverview Room, The Citadel

Coming into Charleston on I-26 take The Citadel/Rutledge Avenue Exit. This will put you on Rutledge Ave. Turn right off Rutledge onto Moultrie Street. Moultrie Street takes you into the main gate (Lesesne Gate) of The Citadel.

Coming into Charleston on Highway 17 from the north (from Georgetown), turn right onto Ashley Avenue. Continue on Ashley to Moultrie Street. Turn left off Ashley onto Moultrie Street. Moultrie Street takes you into the main gate (Lesesne Gate) of The Citadel.

Coming into Charleston from the south on Highway 17, continue over the Ashley River Bridge and stay in the second lane from the right. Just past the first stop light (Wachovia Bank on the right and Hardees on the left), Highway 17 curves to the left, but you will continue straight onto Cannon Street. Turn left off Cannon onto Ashley Avenue. Turn left off Ashley onto Moultrie Street. Moultrie Street takes you into the main gate (Lesesne Gate) of The Citadel.

Refer to the map on the next page. After entering the campus through the Lesesne Gate, go straight as far as you can and take a right onto Hammond Ave. A short distance down Hammond, you will see a grassy hill on the right. The Riverview room is at the top of the hill. Find parking along the street. If you are unable to find parking along Hammond, then proceed to the Visitor parking lot in front of Deas Hall. Walk to Coward Hall and enter from the front. Go upstairs and to the back of the building for The Riverview Room.
